Kids Fair Play Fund provides funding to Shelburne County children and youth from families facing financial barriers so they can participate in recreation, sport, and cultural activities.

Funding Info:

1. Applicants must be aged 18 or younger
2. Funds can be used for registration fees and/or equipment
3. Total funding will not exceed \$250 per application period
4. Application period is April 1st to March 31st
5. Older versions of application forms will not be accepted

Application Info:

1. Approval is based on financial eligibility and Stats Canada's Low Income Cut-Offs
2. Application will not be approved until all information is received
3. Complete applications will receive a letter within one week after submission notifying of the status
4. To determine financial eligibility for funding, **one** of the following must be provided with the application:
 - a. Most recent CRA Notice of Assessment
 - b. Social Income Assistance Statement
 - c. Child Benefit Statement
 - d. Endorsement from the Department of Community Services

Low Income Cut-Offs Before Tax

(determined by Stats Canada)

If applying using a CRA Notice of Assessment please ensure your total income (line 15000) does not exceed the cut offs listed below for your family size. Documents must be provided for each parent in the household.

- 2 person family - \$39,721
- 3 person family - \$48,832
- 4 person family - \$59,288
- 5 person family - \$67,244
- 6 person family - \$75,839
- 7 person family or more - \$84,436

*To calculate family size count the number of parents in the household plus the number of children 18 years or younger.

Example:

- 2 person family = 1 parent + 1 child
- 3 person family = 1 parent + 2 children OR
2 parents + 1 child

1. Fill out the application form and include any documents required to determine financial eligibility
2. Submit the complete application in one of the following ways:
